These documents are to be sent through the affiliating institution duly forwarded by their competent authority. Please see the relevant clauses in the ICSSR Post-Doctoral Fellowship Guidelines available on ICSSR website - www.icsr.org - regarding the affiliating institution, research supervisor and other details.

You are required to join the fellowship within two-three weeks from the date of this letter and send the above mentioned documents, duly completed, within this period, so that a formal letter of sanction could be issued.




